1. Presentation of the site.

2. General terms of use of the site and the proposed services.

These conditions of use are likely to be modified or supplemented constantly, the users of the www.fromagerie-la-revaliere.fr site/are thus invited to consult them in a regular way.

This site is normally accessible constantly to the users. An interruption for technical reason of maintenance can be

however decided by Cheese factory Revalière, which will then endeavour to communicate prior to users the dates and hours of the intervention.

The www.fromagerie-la-revaliere.fr site/is updated regularly by BELEGOU Jean-Yves. In the same way, the legal information can be modified constantly: they are binding nevertheless to the user who is invited as often as possible to refer to it in order to become acquainted of it.

3. Description of the abundant services.

The www.fromagerie-la-revaliere.fr site/has the aim of providing information concerning the whole of the activities of the company.

Cheese factory Revalière endeavours to provide on the www.fromagerie-la-revaliere.fr site/information as precise as possible. However, it could not be held responsible for the omissions, the inaccuracies and the deficiencies in the update, which they are of its fact or the third partners who provide him this information.

All the information indicated on the www.fromagerie-la-revaliere.fr site/is given as an indication, and is likely to evolve. In addition, the information appearing on the www.fromagerie-la-revaliere.fr site/is not exhaustive. They are given subject to modifications having been brought since their setting online.

4. Contractual limitations on the technical data.

The site uses technology Javascript.

The website could not be held responsible for material damages related to the use of the site. Moreover, the user of the site commits himself reaching the site by using a recent equipment, not containing a virus and with a browser of last updated generation.

5. Intellectual property and counterfeits.

Under Firefox: at the top of the window of the browser, click on the Firefox button, then to go in the menu Options. To click on the menu Private life.

Parameterize the Rules of conservation on: to use the parameters personalized for the history. Finally strip it to disable the cookies.

Under Safari: Click in top on the right of browser on the pictogram of menu (symbolized by a wheel). Select Parameters. Click on Displaying the advanced parameters. In the section "Confidentiality", click on Parameters of contents. In the section "Cookies", you can block the cookies.

Under Chrome: Click in top on the right of browser on the pictogram of menu (symbolized by three horizontal lines). Select Parameters. Click on Displaying the advanced parameters. In the section "Confidentiality", click on preferences. In the menu "Confidentiality", you can block the cookies.

9. Applicable duty and attribution of jurisdiction.
